# **Full Job Description**

Mississippi County Health Department is seeking a Community Health Worker/Program Coordinator.

Community Health Worker (CHW)/Program Coordinator will work through the local public health agency and identify underserved populations to assist with education, surveillance, referrals to programs and resources in an effort to mitigate COVID 19 and help control risk factors for chronic disease.

#### **RESPONSIBILITIES:**

- Assuring that people access the coverage and services they need focusing on those with the highest risk of
  poor health outcomes resulting from COVID 19 related illness and those with chronic health conditions
  such as obesity, diabetes, hypertension, heart disease and chronic kidney disease.
- Creating more effective linkages between vulnerable populations and the health care system focusing on those with underlying health conditions.
- Managing care and care transitions for vulnerable populations;
- Collect data on number of clients referred to services and programs that address the social determinants of health and chronic disease.
- Providing culturally appropriate health education on topics related to chronic disease prevention, physical activity and nutrition, and cultural competence;

- Building community capacity to address health issues and stakeholders who are interested in planning for pandemics in the region.
- CHWs offer interpretation and translation services to provide culturally appropriate health education and information to assist people in receiving the care they need.
- Assist with educating community members and groups on how to create a plan to put into place for future pandemic health events.
